I lend my trust to this project being of immeasurable worth, both in terms of historical documentation and in the enrichment of living and active artists.

I have come to know Melinda as an innovative and passionate collaborator, professional, and deeply warm human being. She has a naturally open charisma and ability to connect with everyone, regardless of their state of being, benefit, need or position. Through the numerous projects we have collaborated on together, she has been a surprisingly undaunted source of brilliance when things could have gone a "bit dull or actually disastrous".

We have worked together as artists on projects through RADF funding that I would be proud to claim as the most significant work I've ever done - under her inspirational motivation. When we arrived in central Queensland, specifically at multiple Outback Festivals in Winton and Blackall, she was the driver. Through her unyielding engagement with local youth burgeoning on otherwise 'weird and awkward' opportunities in the fields of music, performance and visual art, we delivered ways for regional communities to experience the true authenticity and talent of their young voices and collective expression. In all my experience, what Melinda was able to pull forward from the youth of regional communities was genuinely beautiful.

As a visual arts facilitator, I've never worked with a musician, performer and vocal instructor as versatile and able to cross boundaries as Melinda. In my experience with her, she never saw a difference in the vision or philosophy for the project 'at large' or let it be a limitation to our cumulative ability to give the community a wholeness. To be completely honest, her ideas for our visual art concepts went far and above her part of the contract we had. She is a true creative savant.

In this understanding, I cannot recommend anyone more than her to meet the regiment of criteria for her approval for this grant. Her passion is coupled with her intelligence and experience – and I know she would never undertake a project that she does not feel able to deliver upon, even if it may lead to a desire for further investigation. She will bind people and find pathways to valuable expression and communication that make the world feel more meaningful. And I would be dumbfounded if you do not find what I found; a person completely and utterly in love with the nature of the human story and it's unfolding pathways.

Melinda Wells and her team of photographer and sound recording expert worked with Bundaberg Child Protection Week Action Group and young people from supporting community agencies to create a signature jingle for our CPWAG mascot, Sunny, during a five day workshop at Central Queensland University campus. As a member of CPWAG, it was a valuable learning experience working with Melinda who assisted us in applying for grants with her extensive knowledge in this area and then observing her organizational and engagement skills with both young people and supporting adults. Her wide network of contacts within the music industry and local community was also very useful. She has excellent planning abilities and evaluated daily to plan for the next day.

Melinda was able to share her musical talents with a wide range of young people in terms of their talent, abilities and emotional needs. She rapidly recognised each young persons' strengths so they were included in the an aspect of the project.
